From the Minutes...

Minutes of the General Meeting

October 14, 2008

The meeting was called to order at 7:35 PM by President Howard Smith.

Visitors - Floyd Urbanski, AB9EX, Dwain Runnells, KC9MJJ, James Wilkins, KC9KEQ, Leroy Hass, KC9NST, Paul Hass, KC9JET and Robert Fetterly, N9HWB, were introduced.

Club members then introduced themselves to our guests.

Minutes - the membership approved the minutes as printed in Hamtrix.

Special Announcements - Howard mentioned that he hoped all club members would be present for: 1) our annual club awards dinner, scheduled for November 9; and 2) for our annual major fund raising event, our swapfest, scheduled for January 3, 2009.

Election - at this time, our annual election of officers was held: for President, Howard Smith, WA9AXQ, was re-elected by motion; for Vice-President Tom Macon, K9BTQ, was re-elected by motion; for Secretary Lynn Tamblyn, K9KR, was re-elected by motion; for Treasurer Dick Wood, W9JBE, was re-elected by motion; Chuck Craven, WA9PUB, was elected as Board Member at Large, for a two year term; and Bob Zach, KC9AGX, was elected to the "Past President" position, for a one year term.

Meeting Start Time - the membership voted to approve a 7 PM starting time for club meetings, to begin with the November 11, 2008 meeting.

Program - Digital Television. Dave Schank, KA9WXN, who works at channels 10/36, presented a comprehensive program on the new digital format that will become the norm as of February 17, 2009, at which time all analog TV broadcasts will cease. This was required by the Deficit Reduction Act. This act basically gives the right to sell off some of the former analog channels. Almost all channel numbers will be changed, with

UHF frequencies being the main location of the new channels. Presently there are some 1631 full power stations already working on their new assignments. Dave indicated that if you receive your TV signals via an antenna, you will need to buy a digital-ready television set or purchase a digital-to-analog converter box. The government is providing \$40 coupons to help defray the cost of these boxes, which sell for \$50 to

\$60 without the coupon. He believes there are some 70 million analog sets that are at risk. Dave mentioned that cable companies will be carrying the converted signals for only three years, so those that receive their TV from cable will have some time to buy a digital TV. He did not know what the cable companies will be doing after the 3 years are up. He then talked about antennas that will be needed. He mentioned a web site of www.antennaweb.org that can be used to determine what antenna you would need for "antenna" reception, once you plugged in the needed information. Rabbit ears will probably not work. He further indicated that for channels 7 to 52, you would need to use RG6 coax, and no preamp. Dave brought along a digital converter box, which he then spoke to - how to hook it up, and do a channel scan. He showed us live TV signals on the club TV as to how the new channels look and how they are numbered - channel 36 has 8 signals, with the channels being 36.1, 36.2, 36.3, 36.4, 36.5, 36.6, 36.7 and 36.8. TV signals will still be 6 Mhz wide, just as present. He showed us some examples of possible problems that will occur with digital TV, the most probable problem being no reception for those on the fringes (those that presently see "snow" for pictures).

Swapfest Ticket Announcement - Chairman Phil Gural took the floor at the conclusion of the program to mention that with the 2009 Swapfest occurring January 3, right after the holidays, he felt it VERY IMPORTANT that the club make a concerted effort to sell as many tickets in advance as possible. He has plenty of them and asked that all members take a number along and sell them. We need to cover our costs in advance if possible, as attendance might be down due to the closeness of the holidays.

The meeting was adjourned at 9:00 PM, followed by refreshments and eyeball QSO's.

WARAC TEN METER CONTEST

DECEMBER 12-14, 2008

Each year around mid-December, the ARRL sponsors a contest for 10-meters only. Along with the League contest, WARAC members have the opportunity to join an additional contest just for our club members.

To participate in the Club contest, enter the ARRL contest as you would otherwise, but while operating, keep an ear open for club members. For every club member worked you get bonus points in the WARAC contest. Follow the ARRL contest rules when operating the contest. They may be found in November QST, or at the ARRL web site: <http://www.arrl.org/contests/rules/2008/10-meters.html>.

The ARRL Ten Meter Contest begins at 6:00 PM CST local

time on Friday, December 12, and runs for 48 hours. You may only operate a maximum of 36 hours during the 48 hour contest time. Note that in Universal time the contest runs from 0000Z December 13, to 2400Z December 14.

For the Club contest you may operate CW only, phone only, or both. CW contacts get a multiplier of two per contact. There are three power levels that apply multipliers to your score, QRP (5 watts or less), low power (5 watts to 150 watts) and high power (150 watts or more). The power multipliers are listed on the Sum-

mary Sheet below.

Calculate your Club score consists of three steps that are included on the summary sheet. First, multiply your CW QSO's by two and then add your phone QSO's to get your Contact Points. Second: multiply your Contact Points by your power multiplier to get Total QSO points. Third: multiply the number of club members worked by five. Add this number to your Total QSO points to get your Final Score for WARAC.

It is recommended that you submit an entry in the ARRL contest, but it is not required for the WARAC contest. Note that the League submission rules require either an electronic log in Cabrillo format

or a hand-written log – no computer printouts. See ARRL rules

for details. N3FJP has a 10-Meter Contest program for \$6.00. It's specifically for this contest and it outputs directly in Cabrillo. You can't go wrong for six bucks!

To submit your entry for the Club contest, send a copy of your ARRL log and a filled-out Club Summary Sheet (below) before January 15, 2009 to Chuck Craven at the address listed at the bottom. Certificates for winners will be given out at next year's Club Awards Dinner.

2 Days After New Years

2008 FIELD DAY RESULTS

This year's Field Day results have been published on the ARRL website and will also be in December QST.

Our W9FK's 1485 QSO's and 5300 points was good for third in Wisconsin in the 2A class and fourth in Wisconsin overall, up from seventh in 2007. Top Wisconsin 2A station was W9EBV, the Fond du Lac ARC, with 2126 QSO's and 7892 points, followed by N9AW, the W/K ARC of Greater Milwaukee with 1618 Q's and 6088 points. Fourth in WI - not bad!

The 2A class that we operated in is the most competitive, as can be seen by the nationwide number of entries in the small table below.

Also noteworthy is the performance of our friends to the north, the Ozaukee Club, who clearly did not live up to their well-known phonetics, Whiskey Nine Lousy Operator. With 35 people participating, they turned in 12816 points, good for first in Wisconsin, second in the ninth call area and 17th in the whole contest. Congratulations to the ORC!

CHECK OUT YOUR LCR

Anyone who has electronically submitted a log for an ARRL contest in recent years has dealt with the League's contest "robot". The robot checks for major errors or omissions and sends you a return email indicating that your log is accepted or, if not, it tries to help you fix it.

During the next few months, the accepted logs are examined in much greater detail and finally the contest results are published. The process of detailed examination is now done with custom software developed by the ARRL for this purpose. A by-product of this process is a very detailed report called a Log Check Report (LCR) for each log. Your LCR's can be accessed on the ARRL web site, but only if you are an ARRL member.

If you're an ARRL member, go to <http://www.arrl.org/members-only/contests/lcr.html> to see what LCR's are available for your callsign. Your LCR's for all contests will be listed there.

In 2007, K9BTQ participated in two ARRL contests; Sweepstakes and the 10-Meter contest. Let's take a look at my 2007 10-Meter contest LCR.

My submitted log claimed 5054 points with 133 Q's and 19 multipliers, but after log checking I was credited with only 4080 points. Somehow I had lost 974 points! What happened? The LCR explains it in almost painful detail.

Four things happened that reduced my score. First, my log listed four QSO's that were not in the other guy's log, therefore they were removed from my log. This is called a NIL (Not In Log) error. In addition to the Q's being removed, a penalty of one "equivalent OSO" is assessed for each NIL, so I actually lost the points for eight QSO's, not four.

Secondly, I had two "busted calls". Busted calls are ones that are in both logs but they don't quite match. For example, one call was KI4AOQ, but I had logged it as KI4AOC. Busts are treated the same as NIL's - the bad calls are removed and equivalent points are deducted.

The third item was that I had one "busted exchange". As you might guess, a busted exchange is where my exchange information doesn't match what the sender sent. Busted exchanges are considered a less serious error so no penalty points are deducted, but the QSO is still removed from the log.

So I had seven Q's removed from my log plus equivalent points for six more, a total of 13 out of 133, or about

10%. So why did I lose 974 points, almost 20% of my score?

Because I lost multipliers. It so happens that two of the Q's that were removed from my log were the only ones worked in a particular state. As a result, I also lost two multipliers and now had only 17 instead of 19. When the score is recalculated, the remaining 126 good Q's in my log are multiplied by 17 instead of 19, resulting in the loss of another 504 points. (Note that there is also a two-point multiplier for power in this contest.)

The end result is that a few fairly simple mistakes cost me a lot of points. So what's the moral of this story? There are a lot of things that you can do to improve your contesting score, but don't overlook the accuracy of your log. If you bust a call or piece of exchange information, today's log checking software will find it and your score will be reduced accordingly. In order to maximize your score, you obviously need to keep errors to a minimum.

One final note. Deductions and penalties on your LCR do not mean that the ARRL thinks you cheated. As with most competitions, if a mistake is made during play there is some sort of penalty. If points are deducted, it simply acknowledges that a mistake was made.

The primary purpose of LCR's is to help you analyze your operating practices, look for ways to reduce errors and improve accuracy. Make use of them!
